Balsamiq makes different versions of its software, here referred as Balsamiq Software. Some you install, some you use online, some you install as a plugin behind your firewall. Different versions have different License Agreement and Terms of Use.

This document describes the Terms of Use for those versions of Balsamiq Software that are used as a plugin to a web application that is hosted in the cloud.

- Balsamiq Mockups 3 for Confluence Cloud & Balsamiq Wireframes for Confluence Cloud (referred together as Balsamiq for Confluence Cloud hereafter)
- Balsamiq Mockups 3 for Jira Cloud & Balsamiq Wireframes for Jira Cloud (referred together as Balsamiq for Jira Cloud hereafter)
- Balsamiq Mockups when used on ux.stackexchange.com

# Access to Your Data / Privacy Policy What Personal Data Do You Collect and Why?

We collect the following personal data:

- Name
- · Company Name
- E-mail address
- Billing Address

We do not collect credit card information directly. See <u>Who can see my credit card number?</u> (<u>#who-can-see-my-credit-card-number</u>) below.

The email addresses we collect for the Balsamiq Plugin customers are used to communicate account activity. This activity may include, but is not limited to, subscription status (renewal, cancelation, etc.), and account ownership verification. Inbound return email addresses are only used to send a reply.

Please be aware that your browser must be enabled to accept cookies from the domain you access the Balsamiq Plugin from in order for you to use the Plugin.

The Personal Data we collect is not shared with third parties, except for the purposes of determining the validity of a subscription payment. In this case, we may share the name and email address of the account owner with the credit card holder, your company's accounting department, or with Stripe when responding to a chargeback.

#### Who Can See My Password?

The Balsamiq Plugin does not request a password of its own, and it does not have access to the platform's password.

#### Who Can See My Credit Card Number?

No-one at Balsamiq. If you bought the Plugin from a platform vendor, please refer to their Terms of Use. If you bought it from us (Balsamiq for Google Drive), we use the very trustworthy and secure <a href="Pin Payments (https://subs.pinpayments.com/">Pin Payments (https://subs.pinpayments.com/</a>) and <a href="Stripe.com/">Stripe</a> (https://stripe.com/</a>) payment services. Read about their security measures on the <a href="Pin Payments Terms and Conditions">Pin Payments Terms and Conditions (https://pin.net.au/terms)</a>) and <a href="Stripe.com/terms">Stripe Terms of Service (https://stripe.com/terms)</a>) (in short, they encrypt your credit card info).

#### **Our Commitment to Children's Privacy**

Protecting the privacy of the very young is especially important. For that reason, we never collect or maintain information at our website from those we actually know are under 13, and no part of our website is structured to attract anyone under 13.

#### **How Can I Access or Correct My Information?**

If you purchased from us, **this article** (/sales/invoice/) explains how to access and edit your information depending on what product you purchased. Otherwise please refer to the platform's Terms of Use documents.

#### Who Can See My Wireframes?

The Balsamiq Plugin follows the access control rules of the platform itself. In other words, if you attach a wireframe made with the Plugin to a wiki page or a bug report, only the platform users who have access to that wiki page or bug report will be able to see it.

If you notice this not being the case, please report the bug to us following the guidelines **below** (#what-should-i-do-if-i-find-a-security-vulnerability-in-your-services).

In order to provide functionality such as autosave and real-time-collaboration, the Google Drive, Confluence Cloud and Jira Cloud plugins store a temporary copy of your projects on our servers, but regularly send the data back to the platform for official storage (as a Google Drive file or as a Jira issue attachment).

We keep this temporary data for 30 days. If there are errors sending it to the platform, we might keep the data for longer, as a backup.

# What Are the Guidelines Balsamiq Follows When Accessing My Data?

- We restrict who at Balsamiq can access customer data to only senior members of the team, and never to outside parties.
- We only do it in response to a customer support question.
- We only do it in order to debug and fix the issue.
- We never make changes to anything unless explicitly requested by you, the paying customer, as defined by your invoice.
- If you ask us to look into a project in order to debug a software issue, we will go in and look at that project and possibly make minor edits in order to fix the issue.
- We never ever share what we see with other customers or the general public.
- We might give access to US authorities if requested in writing. We'll try not to, but we don't have the resources to fight the government. We'll also keep you informed as much as we can if this happens.

#### Who Else Has Access to My Data?

We host the temporary project data on Amazon Web Services (AWS). Specifically, our database runs on RDS. Amazon employees have access to this data. Here's their <u>privacy</u> <u>policy (http://aws.amazon.com/privacy/)</u>. Amazon controls physical access to their locations. We don't control physical access to our locations, other than standard locked doors.

We use secure private keys when accessing servers via SSH, and protect our AWS console passwords locally with 1Password and LastPass.

We log application data (email or platform user id, project id). We rotate logs with 14-days conservation. We stream logs from our servers to our own secure recorder server using SSL.

As mentioned <u>above (#who-can-see-my-credit-card-number)</u>, we rely on Pin Payments and Stripe for payment processing.

We use <u>PubNub (http://www.pubnub.com/)</u> to provide real-time updates, always sent over SSL. Here's their <u>privacy policy (http://www.pubnub.com/privacy-policy)</u>.

# How Is My Data Protected from Another Customer's Data?

Each temporary copy of our customers' data resides in its own database. We use software best practices to guarantee that only people who you designate as editors or viewers of your data can access it.

# How Are You Protecting My Data from Hacker Attacks?

Security is one of the main reasons we chose Amazon Web Services as the infrastructure provider for our servers. It has the best track record out there, look at <a href="mailto:this.article">this.article</a> (<a href="http://money.cnn.com/2010/12/09/technology/amazon\_wikileaks\_attack/index.htm">http://money.cnn.com/2010/12/09/technology/amazon\_wikileaks\_attack/index.htm</a>) for instance.

To see all the steps Amazon takes to protect the data saved on its services, take a look at the extensive **Security And Compliance Center** (http://aws.amazon.com/security/) and the security-related white papers (http://aws.amazon.com/whitepapers/). It's what makes us sleep well at night. AWS is ISO/IEC 27002 certified.

We also have our own practices in place, which follow the industry's best practices. We only give access to our servers to senior Balsamiq security experts, we keep our servers always up to date with security fixes, have one-click ways to take down servers should they become infected/compromised and to create and deploy new clean ones, we always code-review security-related code internally before checking in, have an automated suite of tests against XSS attacks, we use 2-factor authentication whenever possible, and more. We don't run background checks on employees nor have CISSP certifications or have audit logs.

To the best of our knowledge, our service has never been compromised so far.

Should our systems get compromised, we will replace the server(s) that have been hacked with new ones (we can do this with very few clicks). If this doesn't stop the attack, we'll shut down the service until we can fix the vulnerability. We will also hire experts to help us and verify that we're safe to resume service.


For Balsamiq for Google Drive, Balsamiq for Confluence Cloud and Balsamiq for Jira Cloud, we do not guarantee continuous access to the Plugin. Like all other cloud-based applications, we are vulnerable to the inherent unreliability of the Internet.

That said, high reliability is something we are proud of and something we deliberately chose to compete on. That's why we have hired developers, system administrators and support staff both in California and Europe.

We monitor Balsamiq for Google Drive, Balsamiq for Confluence Cloud and Balsamiq for Jira Cloud closely and have set up automated alarms to be notified (via email and SMS) when the service is under stress, so that we can deal with the issue before it becomes a problem that might impact customer access.
